

Competition Terms and Conditions – Layla New Menu competition

By participating in this competition, entrants agree to the following Terms and Conditions:

1. **Promoter:** VenuesLive Management Services Pty Ltd, operator of Layla restaurant, Montague Road West End.
2. **Eligibility:**
 - Entrants must be 18 years of age or older.
 - As the Prize includes alcohol, minors (persons under the age of 18) are strictly prohibited from participating in any aspect of the Prize.
 - The Promoter may require that participants verify their age prior to participating in the Prize.
 - Employees of Queensland Ballet, VenuesLive Management Services Pty Ltd, Shane D Pty Ltd, Shane Delia, and each of their immediate family members are not eligible to enter.
3. **Entry Requirements:**
 - Entry to the competition is free.
 - To enter, participants must follow @layla_brisbane on Instagram, tag three people they would bring to the experience, and include a comment explaining why they would like to share the table with them.
 - Only one entry per person is allowed.
4. **Competition Period:**
 - The competition begins on 13th May 2026 at 9am and ends on Monday 1st June 2026 at 11:59pm. Entries received outside this period will not be considered.
5. **Prize:**
 - The Prize is a dinner at Layla for 4 guests who will be provided the Layla Premium Feast plus wine pairings, valued at over \$900. Any additional food or beverages ordered will be charged at standard rates.
 - The winner must redeem the Prize within three (3) months of being notified that they are the winner, by booking the Layla dinner directly with the Promoter.
 - The Prize will only be available to be used on a Wednesday, Thursday or Sunday.

- If the winner fails to show for the pre-booked dinner or fails to cancel the booking within 24 hours of the reservation, the Prize will be forfeited.
- The Prize is not transferrable and cannot be exchanged or redeemed for cash in part or in full.
- The winner must not use the Prize in conjunction with any promotional offer of the Promoter.

6. Selection of Winner:

- The winner will be selected randomly from all eligible entries after the Competition Period ends.
- The winner will be contacted via Instagram DM to request their contact details within 7 days of the Competition closing date.

7. Claiming the Prize:

- The winner must confirm acceptance of the Prize within 48 hours of being notified.
- The winner will be required to verify their age at the time of confirming their acceptance of the Prize by providing a valid government-issued photo ID (e.g., driver's licence, passport).
- If the winner cannot be contacted (e.g. an email notification is returned as undeliverable; a phone is disconnected), the winner does not respond within this timeframe to claim the Prize, or the winner cannot verify their age, a new winner may be selected from the remaining eligible entries.

8. Data Collection:

- The Promoter collects personal information for the purposes of processing and administering entries to the Competition, and the provision of the Prize.
- The Promoter may disclose entrants' personal information to third parties to assist in conducting the Competition and providing the Prize. - By entering, participants consent to VenuesLive collecting, storing, and using their personal information in accordance with applicable privacy laws.
